## Waiver and Release of Liability

### WAIVER AND RELEASE OF LIABILITY

I acknowledge that I have carefully read this "waiver and release" and fully understand that it is a

release of liability. I expressly agree to release and discharge VICTORY PARTNERS LLC, DBA "THE LAB" AND TRIPLE V PREPARATORY SCHOOL LLC and all of its affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors and assigns, from any and all claims or causes of action and I agree to voluntarily give up or waive any right that I otherwise have to bring a legal action against VICTORY PARTNERS LLC, DBA "THE LAB" AND TRIPLE V PREPARATORY SCHOOL LLC for personal injury or property damage.

In the event that any provision contained within this Release of Liability shall be deemed to be severable or invalid, or if any term, condition, phrase or portion of this agreement shall be determined to be unlawful or otherwise unenforceable, the remainder of this agreement shall remain in full force and effect, so long as the clause severed does not affect the intent of the parties. If a court should find that any provision of this agreement to be invalid or unenforceable, but that by limiting said provision it would become valid and enforceable, then said provision shall be deemed to be written, construed and enforced as so limited.
